- Eligibility Screening Training (Bulletin 2024-006)

MichiCANS PCE Demonstration: A representative from PCE to attend and share examples of the MichiCANS Screener and Comprehensive Assessment via the PCE electronic health record system.

Eligibility Screening: Effective 7/1/2024 cpt code (H0002) will be included in the list of services that do not require an authorization during the intake period for members serviced. In addition, refer to Bulletin 2024-006 Eligibility Screening for a list of modifiers to use with H0002 for special population children screenings (ages 0 to 21st birthday) and CCBHC screenings (all ages).
