

BH-TEDs Error Type- Type of Treatment Service Setting

EMU0720 - Invalid Type of Treatment Service Setting - If Client Transaction Type U, Type of Treatment Service Setting must be 72, 73, 74, 75, or 76

This error type stems from a change the state made in the Type of Treatment Service Setting. It can no longer be MH Individual Assessment Only but must now be MH Community- Based Program.

1. Go to the Consumer's BH-TEDs record
2. Start with a review of the original Admission record
3. If the Admission was done via the Biopsychosocial (IBPS) as the Source Document, there will need to be a Change Signed Document of the IBPS to change the Type of Treatment Service Setting



- a. Go to the Signature Page of the IBPS and click on the unlock button to enable you to change the Type of Treatment Service Setting to MH Community-Based Program
- b. Once you save it, other errors may appear in a red box that you will also need to address before you can sign and save
- c. Once the Admission is completed, you will need to follow the same process for all other TEDS records following the Admission. All of them should have MH Community-Based Program



4. If the Admission record was created by a Stand-Alone TEDs, the Change link can be used to go in and change the Type of Treatment Service Setting

5. If the Admission record already states MH Community-Based Program, then review the Update Records and change those that do not indicate MH Community-Based Program

BH-TEDs Error Type- Type of Treatment Service Setting

1. Example of Admission record created from the IBPS as the Source Document
 - a. Following the above Change Signed Document process, the Admission record on the IBPS was changed to the Type of Treatment Service Setting to MH Community-Based Program
 - b. The MH Update 4/15/19 needs to be changed to MH Community-Based Program as well in order for the TEDS episode to be accepted in full

 - b. All MH Updates are listed as MH Community-Based Program so nothing further is needed on this BH TEDs episode as they will automatically update once the Admission record has been sent
