BACKGROUND

Currently Michigan Department of Health and Human Services (MDHHS) permits certain modifiers for children services Evidenced Based Practices (EBP). It is the goal of DWIHN to develop local modifiers to capture all the children services EBPs to identify members ages 0 to 21st birthday who are receiving EBPs and to measure outcomes of services.

PROCEDURE

Effective 10/1/2023 Children Providers who are currently participating in an EBP Cohort and or have completed an EBP Cohort with MDHHS certification approval are to utilize the identified CPT codes and modifiers according to the chart below. In addition, Providers are also able to resubmit claims effective 10/1/2023 if needed. The revised bulletin is issued to discontinue the use of local modifiers (E1-E4) and replace them with local modifiers (EF, EG, EH, EI, EK). *Refer to chart below*

DEFINITIONS:

- **Evidenced Based Practice:** EBP is a process in which the practitioner combines well researched interventions with clinical experience, ethics, client preferences, and culture to guide and inform the delivery of treatments and services. (National Association of Social Work)
