SUBJECT: Statewide MichiCANS Training

The Michigan Department of Health and Human Services will require the use of the Michigan Child and Adolescent Needs and Strengths (MichiCANS) tool statewide beginning October 1, 2024 in the public mental health system.

The MichiCANS Screener will be used at CMHSP Access Centers. Depending on the results of the screener, the MichiCANS Comprehensive will be used at intake with all infants, toddlers, youth, and young adults ages birth through 20 (day prior to 21) as a standard way to guide initial assessment, initial and ongoing eligibility determinations, and treatment planning needs.

Approximately 5000 Clinical Staff and Clinical Supervisors throughout the state will require **MichiCANS** Certification Training and Certification by October 1, 2024. **MichiCANS** Certification Training and Certification is comprised of (see <u>Table 2</u> below):

- Transformational Collaborative Outcomes Management (TCOM) Orientation (3.5 hours)
- MichiCANS Overview (3.5 hours). Upon completion of trainings, individuals must successfully complete an assessment and receive a 70% or higher, in order to be a certified user of the MichiCANS.

In addition, the Department is offering live virtual **MichiCANS Leadership Training** which is intended for leaders and other staff who (1) are interested in learning about the overview of the TCOM philosophy and MichiCANS tool but (2) will not complete or rate the tool. The Leadership Training is not intended for supervisors who oversee staff that will be completing the MichiCANS tool. This training is appropriate for leadership, utilization management team members, and administrative staff who would like foundational knowledge about the tool.

MichiCANS Certification Training (TCOM Orientation and MichiCANS Overview) is a live virtual training and will begin the first week of April and continue through October. Each Prepaid Inpatient Health Plan (PIHP) and Community Mental Health Service Provider (CMHSP) has been assigned a block of approximately 9 weeks in which to complete their certification training. It is essential that staff prioritize these trainings and register accordingly. Given the number of staff being trained statewide during this time, it is necessary that each PIHP and CMHSP use their designated 9-week period only, to complete training. MDHHS will offer multiple sessions weekly, and staff will be required to register on the designated training platform for training sessions. Limited make-up sessions will be offered after October 1, 2024. Only staff with certification can use the MichiCANS tools so timely training is essential. New hires will be offered additional MichiCANS Certification Training sessions October through December 2024. In addition, the Department will provide regular certification sessions monthly beginning in December of 2024.

The training schedule for PIHPs and CMHSPs can be found in <u>Table 1</u> at the end of this document. It is the responsibility of individual PIHPs and CMHSPs to ensure contracted providers, Certified Community Behavioral Health Centers, and/or Designated Collaborating Organizations (DCO), that will be using the MichiCANS, are informed and included in this training plan.

Additional trainings will occur after MichiCANS Certification Training which include:

- · Action Planning for clinical staff and clinical supervisors- live virtual
- Supervisor Training for clinical supervisors- live virtual
- Supervisor Community of Practice sessions for clinical supervisors- live virtual

The required and optional trainings for each type of staff member are outlined in <u>Table 2</u> at the end of this document.

A separate communication will be sent to the administrative leads approximately 3-4 weeks prior to the time of each training assignment. That communication will include directions for registration. Please ensure that you provide all staff members with this information including contracted providers.

Please consider working with your Electronic Health Record (EHR) vendor to ensure your staff will have the opportunity to see the MichiCANS within your test environment. This could provide opportunity for practice and integration within clinical workflows.
