RE: Health Homes RFI: Seeking New Providers for BHH and SUDHH

The Detroit Wayne Mental Integrated Health Network (DWIHN) is seeking to identify Providers who wish to participate in the Behavioral Health Home (BHH) and/ or SUD Health Home (SUDHH) program in the upcoming Fiscal Year 2025. Interested providers should attend an informational session on Health Homes (dates and links below), and will later complete the Health Home certification packet.

Description: Health Homes are supplementary, optional comprehensive care coordination services available to Medicaid beneficiaries with select diagnoses. Health Homes function as the central point of contact for directing patient-centered care across the broader health care system. Beneficiaries work with an interdisciplinary team at Health Home providers to develop a personcentered Health Home Care Plan to best manage their care. The model also elevates the role and importance of Peer Support Specialists and Community Health Workers to foster direct empathy and raise overall health and wellness. In doing so, this will attend to a beneficiary's complete health and social needs. Participation is voluntary and enrolled beneficiaries may opt-out at any time. Health Homes aim to provide efficient, coordinated, and integrated behavioral and physical healthcare, improve outcomes for people, improve care transitions between primary, specialty, and inpatient settings of care, and reduce healthcare costs.

The certification packets outline the provider's ability to meet Health Home organizational and program requirements. Topics addressed in the certifications include confirming providers meet basic MDHHS and Medicaid requirements, anticipated enrollment, meeting staffing ratios, and the provider's plans and infrastructure to perform the six core Health Home services: Comprehensive Care Management, Comprehensive Transitional Care, Care Coordination, Individual and Family Support Services, Health Promotion, and Referral to Community and Social Support Services.
