BACKGROUND

Historically DWIHN used H0031 for all of our assessments with local modifiers to indicate which tool was used (ex., BI, FS, LO, VO, etc.). MDHHS decided to use H0031 with MDHHS modifiers for the LOCUS and SIS assessments. MDHHS also decided to change the use of H0031; they limited it to staff with Bachelor-level or less staff credentials.

PROCEDURE

Effective 10/01/2024, H0031 will be replaced with new Assessment codes listed in the chart below which lists the old H0031 code in addition to the replacement codes with the appropriate modifiers. DWIHN has decided at this time that Case Managers should bill the assessment code listed below, instead of billing T1017 for Support Coordination or Targeted Case Management services.

CHART

The appropriate Staff credential modifiers, along with the appropriate Assessment modifiers below, must appear on the claim with the billing code.

<u>Home Based services</u> - for children who are enrolled in a Home Based program, see Bulletin 23-001, "Revised Scope for Home Based Services" for how to report the "MichiCANS" assessment.
