SUBJECT:

End of MI Health Link demonstration; Start of MICH HIDE SNP

SERVICE AFFECTED:

Dual Eligible - Medicaid & Medicare insurance

BACKGROUND:

In May of 2015, MDHHS initiated the “MI Health Link” (Dual Eligible) demonstration program at DWIHN and three other CMHs across Michigan. The initial three-year demonstration was extended repeatedly and will finally come to conclusion at the end of calendar year 2025. As a follow-on program, MDHHS has deployed the new “Michigan Highly Integrated Dual Eligible Special Needs Program” (MICH HIDE SNP) to replace the old MI Health Link program to offer seamless care coordinated care for people who qualify for both insurance programs.

PROCEDURE:

DWIHN has expired all the MI Health Link contract programs effective 12/31/2025. DWIHN has deployed new MICH HIDE SNP contract programs with an effective date of 01/01/2026. The new MICH HIDE SNP contracts contain the same procedure codes and rates that were in the old MI Health Link contracts. As usual, we will update the rates annually per the CMS Physician Fee Schedule for the Detroit MAC Locality or DWIHN standard rates, where appropriate.

AUTHORIZATION / CLAIMS:

Effective 01/01/2026, cease using the old MI Health Link contract programs for authorizations or claims and begin using the new MICH HIDE SNP contract program. The MICH HIDE SNP code chart and rate sheet shall be published on the DWIHN website in the same location as the MI Health Link rate sheet.
